

WERV YOU KNOW YOU WANNA: THE RIVER'S SWEET SIXTEEN PUNTA CANA GIVEAWAY CONTEST

RULES

QUALIFY

A total of 30 people will qualify for the grand prize giveaway.

- There will be ten (10) qualifiers taken on-air.
 - Five between 2p-6p 1/2/17 – 1/6/17. Five between 6a-10a 1/9/17 – 1/13/17.
 - These qualifiers must arrive at Draft Picks in Naperville (523 Fairway Dr, Naperville, IL 60563) on Saturday, 1/21/17 before 9:00 p.m. to be entered into the grand prize drawdown.
 - The person calling in to the station as the designated caller must be the same person who appears at the grand prize drawdown; substitute callers (e.g. friends, relatives, co-workers, etc.) or substitute parties claiming the prize **are not allowed and will result in disqualification** at the sole discretion of WERV.
 - WERV is not responsible for delays attributable to webcasting, telephone line unavailability, busy signals on the contest line, operator interference, technical or atmospheric conditions that disrupt the completion of the phone call, telephone system malfunctions, or any other telephone problems which may or may not result from this contest. If the station receives less than the requested number of calls (e.g., only 9 callers when the station is looking for the 10th caller to win) within a reasonable period of time (as determined by the station in its sole discretion), the station reserves the right to reconduct that hourly contest at a later time or cancel that winning opportunity and not award the qualification and/or prize.
 - Limit one qualifier per household.
 - Each on-air qualifier will also receive a \$25 Draft Picks gift certificate.
- Ten (10) people will qualify online using an entry form found on the 95.9 The River website.
 - Qualifying on the website is open 12:01 a.m. 12/30/16 to 10:00 a.m. 1/20/17.
 - Ten (10) qualifiers will be randomly chosen and contacted with instructions.
 - These qualifiers must arrive at Draft Picks in Naperville (523 Fairway Dr, Naperville, IL 60563) on Saturday, 1/21/17 before 9:00 p.m. to be entered into the grand prize drawdown.
 - If an on-line qualifier is unable to be at the giveaway remote broadcast, that qualifier will forfeit their chance at the grand prize drawing and a replacement will be chosen. On-line qualifiers will be given a 24-hour notice if they have been chosen.
- Ten (10) people will be randomly chosen live at the giveaway remote broadcast on 1/21/17 between 6:00 p.m. and 9:00 p.m. at Draft Picks in Naperville (523 Fairway Dr, Naperville, IL 60563).
- Qualifiers must attend the grand prize drawdown in person to be eligible to win the grand prize. No stand-ins will be allowed at the grand prize drawdown.

- If on-air and on-line qualifiers do not arrive by 9:00 p.m., they will forfeit their chance at the grand prize and additional on-site qualifiers will be drawn until 30 total qualifiers are reached.
- Odds of qualifying are dependent upon the total number of contestants who enter the contest.

DRAWDOWN

- A grand prize winner will be chosen via a drawdown at approximately 9:30 p.m. on Saturday, 1/21/17 at Draft Picks in Naperville (523 Fairway Dr, Naperville, IL 60563). Time of drawing is subject to change without notice.
- Once the final 30 qualifiers are chosen in the manner described above, each qualifier will receive one number between one (1) and thirty (30).
- There will be 30 bingo balls inside a bingo drum, numbered 1 (one) through thirty (30).
- One ball at a time will be drawn out of a bingo drum. The person with the corresponding number is eliminated until one person is left. That person is declared the winner.
- In the event of a disagreement, the decision made by the promotions staff of 95.9 The River is final.
- In the event that the grand prize winner does not meet eligibility requirements, declines the prize, or otherwise becomes ineligible, the grand prize will go to the second place winner of the drawdown. This will continue until an eligible winner is determined.
- The Winner bears sole responsibility for all taxes for the prize valued over \$600. The grand prize winner must fill out a W9 and turn it over to 95.9 The River Promotions staff before being allowed to book.
- Once the winner has been chosen and a W9 is filled out completely and turned in to 95.9 The River promotions; then booking documents will be handed over to the winner. The winner then must follow booking rules outlined in the informational packet by Apple Vacations.
- The winner will be responsible for paying all departure taxes, insurance, fees and fuel surcharges, approximately \$615-\$750 per person.

GRAND PRIZE

- The grand prize is a trip for two to the official 95.9 The River “You Know You Wanna...Punta Cana!” vacation March 2nd through March 12th booked through Apple Vacations. The trip includes:
 - Non-stop round-trip flight from Chicago O’Hare to Punta Cana, Dominican Republic
 - Round trip transfers to/from hotel
 - All-inclusive accommodations
 - All meals and drinks on resort
 - Welcome receptions with appetizers and cocktails
 - Daily live broadcasts at the resort
