If the starting pitcher for the Chicago Cubs throws a perfect game as deemed by the official MLB scorekeeper, the randomly chosen contestant will win a total of twenty-five thousand dollars (\$25,000).
- 6. **If** no no-hitter or perfect game is thrown, the randomly chosen contestant will win a gift card to Baker's Square for a free pie!

At no time is it possible for a no-hitter and a perfect game to happen simultaneously.

6. Odds of Winning:

Odds of winning depend on the total number of valid entries.

7. Winner Selection and Notification:

Decisions of Station management with respect to the Promotion are final.
