

**ALPHA MEDIA'S CONTEST-SPECIFIC RULES FOR THE  
WERV-FM / MOST WONDERFUL HOLIDAY SHOPPING SPREE**

***NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.***

**These contest-specific rules should be read in conjunction with Alpha Media's General Contest Rules, which are applicable to all contests conducted by Alpha Media Holdings LLC and/or its subsidiaries (including licensee subsidiaries).**

**CHICAGO PREMIUM OUTLETS, LLC, a Delaware limited liability company s is solely responsible for awarding the Grand Prize (as described in section 5 below)**

Sponsor(s): WERV-FM, (1884 Plain Ave, Aurora, IL) WCCQ-FM (2410 Caton Farm Road, Crest Hill, IL), WSSR-FM (2410 Caton Farm Road, Crest Hill, IL),and CHICAGO PREMIUM OUTLETS, LLC, a Delaware limited liability company s (1650 Premium Outlet Blvd, Aurora IL 60502) (collectively, "Sponsor").

1. Promotional Period: "Most Wonderful Holiday Shopping Spree" contest (the "Promotion) begins on November 27<sup>th</sup>, 2017, at 5amCT and ends at 12pmCT on or about December 9<sup>th</sup>, 2017 (the "Promotional Period").

2. Entry Deadline: The deadline to submit entries is 12:00pmCT on or about December 9<sup>th</sup> 2017.

3. Eligibility Restrictions: The Promotion is open to all legal residents of the United States and the District of Columbia (except NY and FL) who are 18 years of age or older at the time of entry and who live in the Illinois counties of Cook, DuPage, McHenry, Kendall, Kane, Grundy, Kankakee, and Willj. Employees of WERV-FM (the "Station"), its parent, subsidiary, and affiliated entities, its advertising agencies, participating sponsors/promotional partners, other broadcast stations in the Station's listening area, and the members of their immediate families (spouse, parents, siblings or children) or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state, and local laws and regulations. Void outside the United States, in NY and FL, as applicable, and where prohibited.

Grand Prize Winner must sign a winner release form, complete an IRS W-9 form, show a valid state-issued ID/Drivers License that verifies information winner provided on entry form and must be present to win..

Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. Be the correct caller to successfully get through for a chance to qualify for the Grand Prize. At the time of their call entrants must provide all requested information, including their first and last name, complete postal address (street, city, state, and zip code), email address, telephone number, and date of birth. Use of any device to

automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by Station. The contest/sweepstakes administrator's telephone system is the official time keeping device for the Promotion.

- Sixty (60) On-Air Qualifiers total
  - Entry days will be from November 27, 2017 – December 8, 2017
  - Contest will be featured across three (3) Alpha Media stations: WERV-FM, WSSR-FM and WCCQ-FM
  - Thirty (30) qualifiers will be selected during week of November 27- December 2
  - Thirty (30) qualifiers will be selected during week of December 4 - December 8
  - Each station will select ten (10) qualifiers.
  - Participants may only qualify ONCE. There will be no repeat qualifiers.
  - Each on-air qualifier will also receive a qualifying prize that includes: a certificate known as the “Managers Special” from Sparkle Express Car Wash, valued at \$20.00 each and can only be redeemed at Sparkle Express Car Wash locations in Oswego and Joliet. On-air qualifier will also receive a Dry Cleaning Voucher from CD One Price Cleaners, valued at \$5.00 and redeemed at any CD One Price Cleaners locations.
  - Qualifiers MUST be present at 10:00amCT for the start of the Grand Prize Giveaway Drawdown described in section 7 (below).
  - If an on-air qualifier is unable to be at the giveaway remote broadcast, that qualifier will forfeit their chance at the grand prize drawing and a replacement will be chosen.
  - The Sixty (60) On-Air Qualifiers MUST check-in no later than 10:30amCT on December 9th, 2017 at the 95.9 The River (WERV-FM) tent (and MUST show a state-issued photo ID/Drivers License) at the Grand Prize Drawdown Event detailed in section 7.
  
- **ONLINE**– To participate in the contest, entrants will participant in a social media campaign, hosted by the Chicago Premium Outlets. Entrants will be encouraged to share photos on the social media sites, “Instagram” and “Facebook. Winners will be selected aby CHICAGO PREMIUM OUTLETS, LLC, a Delaware limited liability company .

    - Entry days will be from November 27, 2017 – December 6, 2017
    - Twenty Five (25) qualifiers will be selected during the week of November 27– December 6
    - Each on-line qualifier will also receive a qualifying prize that includes: a certificate known as the “Managers Special” from Sparkle Express Car Wash, valued at \$20.00 each and can only be redeemed at Sparkle Express Car Wash locations in Oswego and Joliet. On-air qualifier will also receive a Dry Cleaning Voucher from CD One Price Cleaners, valued at \$5.00 and redeemed at any CD One Price Cleaners locations.
    - If an on-line qualifier is unable to be at the giveaway remote broadcast, that qualifier will forfeit their chance at the grand prize drawing and a replacement will be chosen.
    - CHICAGO PREMIUM OUTLETS, LLC, a Delaware limited liability company will be responsible for contacting the twenty five (25) on-line qualifiers.
    - There no repeat qualifiers. Each participant may only qualify on ONE station, OR with the CHICAGO PREMIUM OUTLETS, LLC, a Delaware limited liability company .
    - The Twenty Five (25) On-Line Qualifiers MUST check-in no later than 10:30amCT on December 9th, 2017 at the 95.9 The River (WERV-FM) tent (and

MUST show a state-issued photo ID/Drivers License) at the Grand Prize Drawdown Event detailed in section 7.

- **EVENT REGISTRATION QUALIFIERS** – To participate in this contest, entrants will be able to register on-site day of the event at December 9 2017 from 10:00amCT until 11:00amCT. Entrants must provide all requested information, including their first and last name, complete postal address (street, city, state, and zip code), email address, telephone number and date of birth. Use of any device to automate entry is prohibited. Entrants may submit multiple entries.
  - Fifteen (15) Event Qualifiers total
    - December 9<sup>th</sup> 2017 at CHICAGO PREMIUM OUTLETS, LLC, a Delaware limited liability company (1650 Premium Outlet Blvd, Aurora IL 60502)
    - Each station will be present day of the event and will have open registration.
    - Entrants must correctly, accurately and completely fill out the contest entry form provided during the dates listed above.
    - Each station will select five (5) qualifiers.
    - A total of fifteen (15) qualifiers will be randomly selected from the eligible entries received.
    - On December 9, starting at 10:00amCT until 11:00amCT individuals will be able to enter the contest on site.
    - Each on-air qualifier will also receive a qualifying prize that includes: a certificate known as the “Managers Special” from Sparkle Express Car Wash, valued at \$20.00 each and can only be redeemed at Sparkle Express Car Wash locations in Oswego and Joliet. On-air qualifier will also receive a Dry Cleaning Voucher from CD One Price Cleaners, valued at \$5.00 and redeemed at any CD One Price Cleaners locations

#### 5. Prizes:

**Qualifying Prize:** A certificate known as the “Managers Special” from Sparkle Express Car Wash, valued at \$20.00 each and can only be redeemed at Sparkle Express Car Wash locations in Oswego and Joliet. On-air qualifier will also receive a Dry Cleaning Voucher from CD One Price Cleaners, valued at \$5.00 and redeemed at any CD One Price Cleaners locations.

#### **Grand Prize:**

- **Grand Prize Shopping Spree Grand Prize, which includes various CHICAGO PREMIUM OUTLETS, LLC, a Delaware limited liability company relator gift cards totaling \$2,000.**

There is no substitution, transfer, or cash equivalent for prizes, except that the station and/or Sponsor may, at its sole discretion and to the extent permitted by law, substitute prizes of comparable value to cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

#### 6. Odds of Winning:

Odds of Winning depend on total number of eligible qualifiers present at the Grand Prize Drawdown Event (described in section 7).

#### 7. Winner Selection and Notification:

Decisions of Station management with respect to the Promotion are final.

- A grand prize winner will be chosen via a drawdown starting at approximately 11:30amCT on Saturday, December 9th, 2017 at CHICAGO PREMIUM OUTLETS, LLC, a Delaware limited liability company (1650 Premium Outlet Blvd, Aurora IL 60502)
- Once the final 100 qualifiers are chosen in the manner described above, each qualifier will receive one number between one (1) and one hundred (100).
- There will be 100 bingo balls inside a bingo drum, numbered 1 (one) through and one hundred (100)..
- One ball at a time will be drawn out of a bingo drum. The person with the corresponding number is eliminated until one person is left. That person is declared the winner.
- In the event of a disagreement, the decision made by the staff of CHICAGO PREMIUM OUTLETS, LLC, a Delaware limited liability company is final.

iii. represent and warrant that: you are at least as old as the age of majority in your state; you have the full legal right, power and authority to grant to Alpha the license provided for herein; you own or control the complete exhibition and other rights to the Materials you submitted for the purposes contemplated in this license; you are either the parent (or legal guardian) of any minor featured in the Materials or have received the express consent of the parent (or legal guardian) for any such minor to appear in the Materials and to enter the minor's likeness in the Materials in the contest; and neither the Materials nor the exercise of the rights granted herein shall infringe upon or violate the right of privacy or right of publicity of, or constitute a libel or slander against, or violate any common law or any other right of, any person or entity.

d. Prior to awarding any prize or prize certificate, and depending on the nature of the prize and eligibility requirements of the Promotion, Alpha in its sole discretion may require verification of Promotion winner's or winners' identification by a showing of valid government-issued photo identification.

e. Alpha may also require eligible Promotion winner(s) and their guests or travel companions, if any (as well as each of their parent(s) or legal guardian(s), if winner(s), guest(s) or travel companion(s) are under the age of majority in their state of residence), to sign a liability release confirming such consent. f. Any attempt by an entrant or any person to deliberately damage any station website, Facebook Page, and/or any other social networking site used in the Promotion or to undermine the legitimate operation of this Promotion may be a violation of criminal and civil laws. Should such an attempt be made, the Alpha reserves the right to seek full prosecution and/or damages from any such individual to the fullest extent permitted by law. The station's failure to enforce any term of these Official Rules shall not constitute a waiver of this provision. If due to circumstances beyond the control of the station conducting the Promotion, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the station reserves the right,

but not the obligation, to modify, terminate, suspend or cancel the Promotion and shall not be required to award a substitute prize.

g. Further, the Released Parties are not responsible if any part of a Promotion prize cannot be awarded due to acts of god, acts of war, natural disasters, weather, acts of terrorism or other factors beyond Alpha's control.
